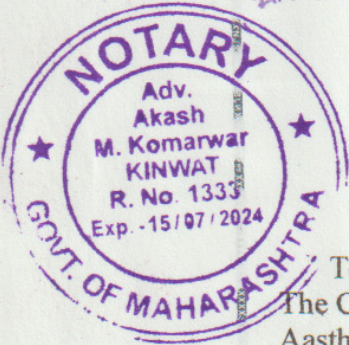

With reference to the above, it is informed to you that your trust had submitted a proposal for establishment of new school and Upgradation of existing school in the year 2018-19 under the Maharashtra selffinanced Schools (Establishment and Regulation) Act 2012. As per the said proposal your trust has been given the permission for establishment of new school and Upgradation of existing school under following terms and conditions, as per government resolutions No. 1 to 3 under reference.

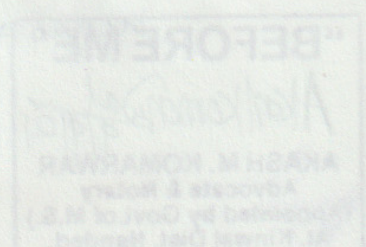
Terms and Conditions :-

1. Primary and Higher Primary schools will comply the provisions of Right of Children to Free and Compulsory Education Act, 2009(Annexure-1) and all the rules / provisions made thereunder.
2. Permission (Letter of intention) is given to start the schools for then year 2018-19 as under on compliance of eligible school management of Act 2009 and provisions thereunder.

A) The management decided to be eligible as per this Government Resolution for the year 2018-19, shall comply and start the school within 18 months with all the conditions from the date of this government resolution if all the necessary facilities are not available with the school management for establishing school or up gradation, as per said government rules, otherwise then permission given shall automatically stand cancelled.

B) Management/Educational Institution, who are given permission as decided to be eligible, desiring of getting affiliation for the syllabus of educational boards viz. CBSR, ICSE, IB, IGCSE and CIE etc. will apply for N.O.C. as per government provisions and policies in detail as mentioned in Government Resolution dated 20/06/2012. On completing the prescribed rules, terms and conditions by the said schools, Government School Board shall give the NOC certificate to the school.

3. It will be binding on the new schools / upgraded schools given permission to comply with all the provisions of the orders and procedures issued by government from time to time as well as all provisions of Maharashtra self financed Schools (Establishment and Regulation) Act 2012 (01 of year 2013).
4. It will be the responsibility of concerned Education officers (Primary & Secondary) to inform these orders to management / institutions immediately.
5. There will be no change in future in the medium, place of school etc. mentioned in then permission as demanded by the Institution school. If the school is started at any other place than the place for which permission is



granted, the permission given by the government shall stand automatically cancelled.

6. U DISE DATA - While uploading the district wise information U-DISE (United District Information system for Education) by the new schools / upgraded schools given permission by this government resolution, will be bound to get the number registered under separate category "Permitted school under Self-financed principle". State Project Director, Maharashtra Primary Education Council, Mumbai is declared as the Nodal Officer for necessary procedure in the matter. So also, the institution shall affix a public Board at the entrance gate outside the school mentioning "Permission granted New School/Upgraded school under Self-financed school principal"
7. Teachers and Non-teaching staff will be recruited by the Permission granted self-financed schools as per prevailing government rules and policies.

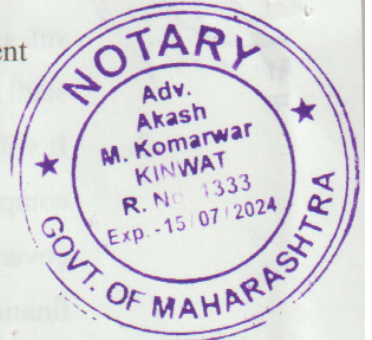
Hence first department permission of the office is given subject to above conditions.

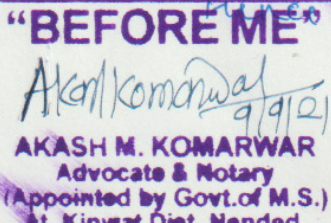
